

**2024 COUNTY-CITY CREDIT UNION PACKER TICKET SWEEPSTAKES
OFFICIAL RULES**

- 1. NO PURCHASE, CREDIT CARD, OR OBLIGATION NECESSARY TO ENTER OR WIN. NON-PURCHASE ENTRIES AND PURCHASE ENTRIES HAVE AN EQUAL CHANCE OF WINNING.**
- 2. ELIGIBILITY:** Open only to members of County-City Credit Union, or individuals who live or work within County-City Credit Union's field of membership, including: Jefferson County, WI; the City of Watertown, WI; the City of Whitewater, WI; or the Village of Cambridge, WI. Open only to legal residents of the United States, age 18 or older, as of September 1, 2024. Employees and volunteers of County-City Credit Union, and their immediate family are not eligible. Void where prohibited and subject to all applicable federal, state and local laws.
- 3. PROMOTIONAL PERIOD:** Sweepstakes begins at 12:01 AM Central Time on September 1, 2024 and ends at 11:59 PM Central Time on October 12, 2024.
- 4. TO ENTER:** Limit one (1) entry per person. There are three options for entering the sweepstakes: **1) Automatic Entry for opening a new County-City Credit Union VISA Platinum Credit Card:** Participants will automatically receive one (1) entry for opening a new County-City Credit Union VISA Platinum Credit Card during promotional period, subject to membership eligibility and requirements, credit application, creditworthiness, and credit review and approval by County-City Credit Union. Automatic entry will be made in the name of the primary person in whose name the County-City Credit Union VISA Platinum Credit Card account used to enter the promotion was issued to; or **2) Automatic Entry for completing balance transfer(s) aggregating \$1,000 USD or more:** Participants will automatically receive one (1) entry for completion of balance transfer(s) aggregating \$1,000 USD or more during promotional period, from outside creditor(s) to a County-City Credit Union VISA Platinum Credit Card, subject to membership eligibility and requirements, credit application, creditworthiness, and credit review and approval by County-City Credit Union. Automatic entry will be made in the name of the primary person in whose name the County-City Credit Union VISA Platinum Credit Card account used to enter the promotion was issued to; or **3) Enter by U.S. Mail Without Making a Purchase:** Hand-print your name, address, city, state, ZIP code, email, and daytime and evening telephone numbers (including area code) on a 3" x 5" card, and mail, in a #10 envelope with postage affixed, to: County-City Credit Union, 106 E John St, Jefferson WI 53549. Each mail-in entry will count as one (1) entry into the drawing. Mail-in entries must be postmarked by October 12, 2024 and received by October 17, 2024 to be eligible. Each mail-in entry must be mailed in a separate, postmarked-and-stamped envelope. Entries that are mechanically reproduced, copied, illegible, incomplete, postage-due or inaccurate, or by any means subvert the entry process are void. Entries become the property of County-City Credit Union and will not be acknowledged or returned.

Only one (1) entry will be allowed into sweepstakes per person, regardless of number of above-listed entry options completed by entrant. Incomplete entries or entries not complying with these Official Rules are subject to disqualification at County-City Credit Union's sole discretion. Other restrictions may apply.
- 5. DETERMINATION OF WINNER:** Potential winner will be selected in a random drawing on or about October 18, 2024, from among all eligible automatic and mail-in entries received and combined. Random drawing will be conducted by County-City Credit Union under dual control by two authorized credit union representatives. Potential winner will be notified by telephone and/or U.S. Mail within five (5) days of drawing. Inability to contact potential winner within a reasonable time period at phone number and address on record, will result in potential winner's disqualification and, at County-City Credit Union's sole discretion, the awarding of the prize to a potential alternate winner.
- 6. PRIZE DESCRIPTION: One (1) Grand Prize:** Two (2) Tickets to the Green Bay Packers vs. Detroit Lions game at Lambeau Field on Sunday, November 3, 2024 at 3:25 PM Central Time. **Total Approximate Retail Value ("ARV") of the Grand Prize is \$578.00.** No substitutions, cash equivalents, or transfer of prize will be permitted, except at the sole discretion of County-City Credit Union, which reserves the right to substitute prize with one of comparable or greater value at its sole discretion. All federal, state, and local taxes, and any other costs and expenses associated with prize acceptance and use are the sole responsibility of the winner. County-City Credit Union will not replace any lost or stolen tickets, nor be responsible for any cancellations, delays, or other restrictions/conditions. Tickets are subject to certain terms and conditions as specified thereon. Online Ticket Master account may be required for winner to claim the prize tickets. Winner and his/her guest are responsible for complying with all ticket, venue, stadium, and event terms, conditions, rules and regulations.
- 7. ODDS:** Actual odds of winning the Grand Prize depend upon the total number of eligible entries received.
- 8. CONDITIONS OF PARTICIPATION:** By entering, participants agree to be bound by these Official Rules, including all eligibility requirements and decisions made by County-City Credit Union, which are final and binding. By accepting a prize, winner consents to the use of his/her name, image, photograph, or likeness for advertising, publicity, and promotional purposes by County-City Credit Union without additional compensation, notification, or permission, except where prohibited by law. Participants release and hold County-City Credit Union harmless from any claims, actions, personal injury, death, loss, or damage of any kind, resulting (directly or indirectly, wholly or in part) from participating in this Sweepstakes or from the acceptance, possession, use or misuse of prize (including travel/activity related thereto). This is a comprehensive limitation of liability which applies to damages of any kind, including (without limitation) compensatory, direct, indirect, or consequential damages; loss of date, income or profit; loss of damage to property; and claims of third parties.
- 9. GENERAL:** County-City Credit Union will not share entrant information with any third party. County-City Credit Union is not responsible for lost, late, illegible, misdirected, inaccurate, incomplete, undelivered, damaged, delayed, or non-received entries. County-City Credit Union may, in its sole discretion, void any entries it suspects impair the fairness or integrity of the sweepstakes. Any attempt by an entrant or other individual to damage or undermine the legitimate operation of the Sweepstakes may be in violation of criminal and civil laws and, should such an attempt be made, County-City Credit Union reserves the right to seek damages and other remedies (including attorneys' fees) from any such person to the fullest extent permitted by law. Except where prohibited, all issues and questions concerning these Official Rules, or the rights and obligations of participants and County-City Credit Union in connection with the sweepstakes, shall be governed by the laws of the State of Wisconsin. Jurisdiction and venue shall be solely within the state of Wisconsin.
